Additions to the plaster mortar, consisting mainly of gypsum, were tried to inhibit the salt efflorescence and the damage to the archaeological plaster. By adding some additives basically talc and other materials to gypsum mortar, without any loss of gypsum mortar component due to the crystal pressure of the salt.
